WHAT?

- A Double Degree programme is **taught at two campuses.**
- **Students will obtain two degrees from both participating institutions,** the University of Limerick and the Université de Franche-Comté.



WHY?

- A Double Law Degree programme aims at giving students in-depth knowledge of the **two main types of Legal Systems** :
 - *Common Law like in the UK, the USA, Canada*
 - *Civil Law like in most European countries*
- A Double Degree programme also aims to **give students skills required in a post-Brexit world where knowledge about the European Union and key member states will significantly enhance students' career options.**
- The programme gives a **more comprehensive understanding of the reality of the European Union** by the lived experience in a different member state in terms of size, culture (incl. academic culture), language and location.





- In order for the system to work, we believe the programme should be kept small.
- A total of 10 students will participate in the programme.

Dedicated Team

- In each structure, one person is responsible for the Double Degree.
- Students benefit individual follow-up

Tuition fees

- There are **no tuition fees in France** (administrative fees of approximately 300€) or in Ireland
- For French students grants are possible (la Bourse CROUS est maintenue en Irlande)
- In Limerick and Besançon, there is on campus accommodation and restaurants.
